Nebraska Environmental Trust Grants Committee Meeting Tuesday, October 22, 2024 1:00 p.m.

#### 1. Call to Order

Committee Chairman Mr. Kanger called the Grants Committee meeting to order at 1:00 p.m. in Suite 310 at 2077 N St, Lincoln, Nebraska.

Advanced notice of the meeting was published in the Lincoln Journal Star on October 16, 2024. The agenda and documents to be considered at the meeting were provided. The Open Meetings Act was posted near the meeting room entrance and on the Nebraska Environmental Trust website.

Roll call was conducted, and a quorum was present.

### 4. Determination of Eligibility of Applications for Grant Funding

# a. Determination of Eligibility of Applications for Grant Funding: Eligible Grant Applications Recommended to NET Board for Consideration

Executive Director Mr. Elmshaeuser gave his recommendations as per his obligation under Title 137: "The Executive Director shall review the eligibility criteria to provide an eligibility recommendation to the Grants Committee. The Grants Committee of the Board shall review each such application and shall make a preliminary recommendation of approval or rejection of the proposal for eligibility based on the recommendation of the Executive Director." Executive

Director Mr. Elmshaeuser outlined his recommendations regarding which grants should be deemed eligible. Executive Director Mr. Elmshaeuser noted that while some grants are determined by the committee to be eligible that there may be some issues in the future with certain grant applications if they are moved on to scoring or are awarded.

**Motion by** Mr. McCoy, seconded by Mr. Helgoth, "I move to determine that grant applications 25-161, 25-164, and 25-160 are eligible and forward to the NET Board for review and approval."

**Discussion:** Discussion centered around the public/private benefit of these projects and whether the environmental education component was sufficient to have the projects fit within one of NET's funding categories.

**Motion as amended by** Mr. Hansen, seconded by Mr. Helgoth, "I move to remove 25-136 from the eligibility recommendation."

**Discussion:** Discussion centered around the eligibility questions #5 (04.001.02), #6 (04.001.02) and #8 (04.003). Concerns were raised about whether the irrigation district was regulatorily mandated to do maintenance. Concerns were voiced about whether the grant application met the standard of one of the five funding categories for NET due to the nature of the proposed resource to be managed. Mr. McCoy noted that, while a grant may be deemed

eligible, that they may not do well under scoring and that eligibility determinations are far less subjective than scoring.

# b. Determination of Eligibility of Applications for Grant Funding: Grant Applications Not Eligible Recommendations

As per Title 137, Executive Director Mr. Elmshaeuser gave an overview of his recommendations regarding which grants could be deemed ineligible. Executive Director Mr. Elmshaeuser discussed the reasons why each grant could be deemed ineligible with his explication centering largely around the statutory requirements underlying his recommendations. Special attention was made toward determining the quantitative public benefit as outlined within each grant application, the scope of said benefit, and whether the subjective nature of the public/private benefit should affect eligibility.

**Motion by** Mr. McCoy, seconded by Mr. Helgoth, "I move to determine that grant applications 25-103, 25-120, 25-125, 25-151, 25-157, 25-158, 25-159, 25-119, and 25-133 are not eligible and forward to the NET Board for review and affirmation."

**Discussion:** Public and private entities are welcome to apply for NET grants and will not be deemed ineligible based solely on the nature of the entity itself.

#### **BACKGROUND**

The Grants Committee is presented with spreadsheets and documents that use a score for each grant application that is ranked to assist in developing a funding recommendation for the 2025 Grant Cycle to be presented to the Nebraska Environmental Trust Board.

#### **EXPLANATION**

Neb. Rev. Stat. § 81-15,175

- (2) establishes the process for a rating and ranking of grant applications. (NET Board approved on May 2, 2024)
- (5) "The board may establish a subcommittee to rate grant applications. If the board uses a subcommittee, the meetings of such subcommittee shall be subject to the Open Meetings Act. The subcommittee shall (a) use the rating systems established by the board under subsection (2) of this section, (b) assign a numeric value to each rating criterion, combine these values into a total score for each application, and rank the applications by the total scores, (c) recommend an amount of funding for each application, which amount may be more or less than the requested amount, and (d) submit the ranked list and recommended funding to the board for its approval or disapproval."

#### **PROPOSAL**

The Grants Committee will review the presented documents and create motions to recommend projects for funding.

<u>Proposed motion:</u> "I make a motion that the grant applications *must have* <u>X#</u> of points or more to be considered for available funding. Applications must meet the application requirements of financial documentation, administration limits, cash match, real estate requirements, and required documentation by the Executive Director as directed in Title 137 prior to allocation of a grant contract."

<u>Proposed motion:</u> "I move that the Grants Committee recommends project (25-\*\*\*), for the following amount (\$\*\*\*\*\*\*) and to be moved on for consideration by the Nebraska Environmental Trust Board".

<u>Proposed motion:</u> "I move that the Grants Committee recommends projects (25-Listed), for the full requested amounts and to be moved on for consideration by the Nebraska Environmental Trust Board".
